The Committee considered Memorandum 2024-03, which presented an update on 2023 crime statistics.

The Committee discussed driving under the influence of alcohol or drugs and the ideas presented by the panelists. After discussion, the Chair directed staff to research the following topics:

- Blood alcohol content level and diversion for many first-time DUI offenses. Staff should research the impact of lowering the per se blood alcohol level to 0.05%, with a particular emphasis on racial disparities in arrests and incarceration and predicted impact on road safety.
- *Expand the use of collaborative courts*. Staff should consider the role state-wide rules can play in expanding the use of collaborative courts.
- *Streamline license suspension*: Staff will continue researching this issue.

The Committee also heard public comment.

Administrative Matters

The Committee considered Memorandum 2024-02 presenting draft Minutes for the Committee's November 2023 meeting.

The Committee approved the Minutes without change.
