CLRC Staff Note. This document, the first of two parts, lists sections and Official Comments affected by 2002 Cal. Stat. chs. 68, 71, 72, 94, and 138 — five bills sponsored by the California Law Revision Commission in the 2002 legislative session. This list correlates to the Comments, meaning that there is a Comment for each entry in this list and there should not be any Comments for sections that are not listed here.
