

TABLE OF SECTIONS AFFECTED BY 2003
COMMISSION LEGISLATION: PART 1

CLRC Staff Note. This document, the first of two parts, lists sections and Official Comments affected by 2003 Cal. Stat. chs. 22, 32, and 149 — three bills sponsored by the California Law Revision Commission in the 2003 legislative session. This list correlates to the Comments, meaning that there is a Comment for each entry in this list and there should not be any Comments for sections that are not listed here.

- As to Chapter 22 (Mechanics Lien), the provision was recommended in *Stay of Mechanic's Lien Enforcement Pending Arbitration*, 30 Cal. L. Revision Comm'n Reports 307 (2000). However, the Comment to Code of Civil Procedure Section 1281.5 was revised during the legislative process. The revised Comment will be set out in an appendix to the Commission's next Annual Report (referred to as "33:apx4"). The pagination for that report is not yet known.
- As to Chapter 32 (Probate Cleanup), references are to the original comments in *Probate Code Technical Corrections*, 33 Cal. L. Revision Comm'n Reports 145 (2003) (referred to as "33:145").
- As to Chapter 149 (Trial Ct. Restruct.), most references are to the original comments in *Statutes Made Obsolete by Trial Court Restructuring: Part 2*, 33 Cal. L. Revision Comm'n Reports 169 (2003) (referred to as "33:169"). However, the Comment to Penal Code Section 830.1 was revised during the legislative process. The revised Comment will be set out in an appendix to the Commission's next Annual Report (referred to as "33:apx5"). The pagination for that report is not yet known.
