

TABLE OF SECTIONS AFFECTED BY 2003
COMMISSION LEGISLATION: PART 2

CLRC Staff Note. This document, the second of two parts, lists sections and Official Comments affected by 2003 Cal. Stat. chs. 379 and 557 — two bills sponsored by the California Law Revision Commission in the 2003 legislative session. This list correlates to the Comments, meaning that there is a Comment for each entry in this list and there should not be any Comments for sections that are not listed here.

- As to Chapter 379 (Exemptions), references are to the original Comments in *Exemptions from Enforcement of Money Judgments: Second Decennial Review*, 33 Cal. L. Revision Comm'n Reports 113 (2003) (referred to as "33:113").
- As to Chapter 557 (Common Int. Dev.), three references are to the original Comments in two Commission recommendations: *Organization of Davis-Stirling Common Interest Development Act*, 33 Cal. L. Revision Comm'n Reports 1 (2003) (referred to as "33:1") and *Common Interest Development Law: Procedural Fairness in Association Rulemaking and Decisionmaking*, 33 Cal. L. Revision Comm'n Reports 81 (2003) (referred to as "33:81"). Most of the Comments were revised during the legislative process. The revised Comments will be set out in an appendix to the Commission's next Annual Report (referred to as "33:apx6"). The pagination for that report is not yet known.
