

## Memorandum 2013-35

**Fish and Game Law: Revised Provisions in  
Proposed Division 2 (Administration)**

---

At its June 2013 meeting, the Commission considered Memorandum 2013-30 and Memorandum 2013-31,<sup>1</sup> which discussed public comment on issues relating to Division 2 of the proposed Fish and Wildlife Code (“Administration”). The Commission approved a number of revisions to the content of Division 2. This memorandum presents a draft of the revisions. The Commission should decide whether to approve them, with or without further changes.

Unless otherwise indicated, all statutory references in this memorandum are to the Fish and Game Code.

## TRANSLATION OF REPORTS

The Commission directed the staff to prepare a revised version of proposed Section 50, which includes language authorizing the Department of Fish and Wildlife to translate statements and reports into languages other than English, at its discretion.<sup>2</sup>

Language to effect that change is set out below. Differences from the version of proposed Section 50 provided in the attachment to Memorandum 2013-12 are shown in strikeout and underscore.

**§ 50. Use of English in statements and reports**

50. Whenever any statement or report is required to be made, it shall be made in the English language. Nothing in this section shall prohibit the department from providing an unofficial translation of a statement or report in a language other than English.

The Commission welcomes written comments at any time during its study process. Any comments received will be a part of the public record and may be considered at a public meeting. However, comments that are received less than five business days prior to a Commission meeting may be presented without staff analysis.

**Comment.** The first sentence of Section 50 continues former Section 7 without change. The second sentence is drawn from Code of Civil Procedure Section 185. It authorizes, but does not require, unofficial translation of statements and reports into languages other than English.

#### RULEMAKING FACTORS

The Commission decided that proposed Section 560 should be revised so that it applies to rulemaking under proposed Section 565,<sup>3</sup> thus:

**§ 560. Factors to be considered**

560. When adopting regulations pursuant to Section 555 or Section 565, the commission shall consider populations, habitat, food supplies, the welfare of individual animals, and other pertinent facts and testimony.

**Comment.** Section 560 continues former Section 203.1 without change, except as indicated below:

The following nonsubstantive change was made:

- A cross-reference to former Section 203 was updated.

The following substantive change was made:

- The provision was made applicable to rulemaking under Section 565.

**Is that language acceptable?**

#### SPOTTED FAWNS AND SPIKE BUCKS

The Commission decided that proposed Section 575(a)(4) should be revised to make clear that it flatly prohibits the adoption of a regulation permitting the taking of spotted fawns and spike bucks.<sup>4</sup>

The manner in which that revision is made is contingent on how the Commission decides to handle the existing distinction between “Article 1 Rulemaking” and “Non-Article 1 Rulemaking,” which has been discussed at

length in prior materials.<sup>5</sup> The Commission has not yet made a decision on that issue, in part because it is awaiting input from the Fish and Game Commission.<sup>6</sup>

#### RULEMAKING CROSS-REFERENCES

The Commission decided that proposed Section 575(b)-(c) should be deleted.<sup>7</sup> Again, the drafting of that change will need to wait until the Commission has decided how to handle the Article 1 rulemaking issue.

#### TERMINOLOGY

##### **“Fish and Game Warden”**

The Commission has decided that the term “fish and game warden” should be replaced with “wildlife officer” throughout the proposed Fish and Wildlife Code.<sup>8</sup>

There are two provisions of proposed Division 2 that need to be revised to implement that decision.<sup>9</sup> However, the staff intends to move both of those provisions to proposed Division 3 (“Enforcement”).<sup>10</sup>

For that reason, the revisions are not set out here. Instead, they will be incorporated into the draft of Division 3 that will be attached to Memorandum 2013-41.

##### **“Sportsmen’s Show”**

The Commission decided to revise proposed Section 1255 to replace the term “fish and game” with “fish and wildlife” and to replace the term “sportsmen’s show” with “hunting or sport fishing show.”<sup>11</sup>

As shown in the text of proposed Section 1255 that is set out below, the term “sportsmen’s show” is being used in a disjunctive list. That makes use of the conjunction “or” in “hunting or sport fishing show” somewhat awkward. For that reason, the staff suggests a slightly different phrasing:

### § 1255. Educational displays

1255. For the purpose of exhibiting fish and ~~game~~ wildlife educational material at fairs ~~or sportsmen's~~ , hunting shows, or sport fishing shows and making other public displays, and to make conservation educational materials on fish and ~~game~~ wildlife available for any public use, including fairs, ~~sportsmen's~~ hunting shows, sport fishing shows, schools, and civic organizations, the department may:

(a) Accept on behalf of the State donations of money and services from any person to defray any expenses that may be incurred by the department in connection with those activities.

(b) Charge admissions or make a charge for the use of any departmental material or exhibits to be used in a fair, ~~sportsmen's~~ hunting show, or sport fishing show, or by a civic organization.

**Comment.** Section 1255 continues former Section 1005 without change, except as indicated below:

The following nonsubstantive changes were made:

- The word "such" was replaced with "any."
- The word "therewith" was replaced with "with those activities."
- The words "fish and game" were replaced with "fish and wildlife."
- The words "sportsmen's show" were replaced with references to a "hunting show" and "sport fishing show."

### Is that language acceptable?

#### AGREEMENT WITH PRIVATE ENTITY

The Commission decided to revise proposed Section 1310 to read as follows:<sup>12</sup>

### § 1310. Funding agreements

1310. Notwithstanding any other provision of law, the department may enter into one or more agreements with any person, nonprofit organization, or other public or private entity, as may be appropriate, to assist the department in its efforts to secure long-term private funding sources for purposes relating to conservation programs, projects, and activities by the department. The authority to enter into agreements ~~for the purposes of~~ under this section shall include, but not be limited to, ~~for the purposes of~~ securing the authority to secure donations, memberships, corporate and individual sponsorships, and marketing and licensing agreements.

**Comment.** Section 1310 ~~continues~~ restates former Section 1227 without substantive change.

**Is that language acceptable?**

FISH AND WILDLIFE DISTRICTS

The Commission decided that the provisions defining Fish and Wildlife Districts should be revised to (1) name each district after the code section that describes the district and (2) expressly authorize reference to districts by their former names.<sup>13</sup> The Commission directed the staff to prepare a revised draft of the district provisions, consistent with those decisions.

Because of the length and technical complexity of the district provisions, the revisions are not set out in this memorandum. Instead, a draft of the revised sections is attached.

To make the revised provisions more readable, the revisions are not shown in strikeout and underscore. However, to simplify the process of confirming that all references to districts have been updated, each use of the word “district” has been bolded.

**Is the language set out in the attached draft acceptable?**
