### **Approval of Actions Taken**

Unless otherwise indicated, the Committee decisions noted in these Minutes were approved by all members present at the meeting. If a member who was present at the meeting voted against a particular decision, abstained from voting, or was not present when the decision was made, that fact will be noted below.

#### **New Business**

The Committee considered Memorandum 2025-01, which discusses survivors of intimate-partner violence as criminal defendants and related matters.

The Committee received presentations from the California Policy Lab about trends in incarceration, particularly prison sentences, for women in California, and from the Stanford Criminal Justice Center about the prevalence and impact of intimate-partner violence among women incarcerated for homicide in California's prisons.

The Committee heard from panelists on the following topics:

- Self-Defense for Survivors (David Andreasen, Wendy Howard, Elizabeth Sheehy, Sandra L. Babcock)
- Coercion and Related Sentencing Considerations (Jamie Beck, Kate Mogulescu, Tracy Prior)

The Committee also received a presentation from Justin Dews, Chair of the New Jersey Clemency Advisory Board, on clemency initiatives.

The Committee is grateful for the participation of all of the panelists and presenters.

The Committee considered Memorandum 2025-01, which discusses survivors of intimate-partner violence as criminal defendants and related matters as well as ideas presented by the panelists. After discussion, the Chair directed staff to research the following topics:

- Retroactivity: Allowing retroactive application of the *People v. Collins* decision from the California Supreme Court. Also consider whether a more general retroactivity principle applying to court decisions should be in the Penal Code.
- Self-defense: For cases involving intimate-partner violence where the defendant is accused of killing their abuser, specifying that self-defense is allowed when used to prevent or escape a threat of ongoing, life-threatening domestic abuse and update how "imminence" and "acting from fear alone" are considered in this context. Include discussion of the Model Penal Code's self-defense standard.
- Coercion defense: Clarifying the legal standard, including by specifying facts that support the defense and the role that coercive control plays.
- Gender stereotypes: Expanding or creating a similar statutory framework as the Racial Justice Act to include gender-based bias.
- Clemency: Updating the Committee on the development of regulations by the Board of Parole Hearings addressing how clemency investigations should occur.
- Vactur: Specifying that courts have the ability to assign counsel in motions to vacate convictions based on IPV as provided in Penal Code § 236.15.

The Legal Director gave a presentation on Memorandum 2025-03, which presented an update on violent crime statistics for yearend 2024.

The Committee also heard public comment.

## **Administrative Matters**

The Committee considered Memorandum 2025-02 presenting draft Minutes for the Committee's November 2024 meeting.

The Committee approved the Minutes without change.
