

## Memorandum 2020-26

**Emergency-Related Reforms  
(Sunset Dates)**

---

At its May meeting, the Commission<sup>1</sup> decided to dedicate part of its staff resources to emergency-related reforms related to the COVID-19 pandemic.<sup>2</sup> As part of this work, the staff reached out to legislative staff to determine whether the Commission could provide assistance with addressing January 1, 2021 sunset dates in the codes.<sup>3</sup> Legislative staff was receptive to the Commission's offer of assistance on this topic.

Attached to this memorandum is a draft informational report related to the January 1, 2021 sunset dates for the Commission's consideration. This informational report is intended to assist the Legislature in deciding whether and how to address the different sunset provisions.

## NATURE OF REPORT

Given the nature of this work, time is of the essence. The report largely addresses the state of pending legislation and is offering information for possible legislative action in the coming months. For this reason, finalizing the report through the Commission's traditional process, which takes multiple months, is simply not feasible.

For this reason, the attached draft is prepared as an informational report, without a formal Commission recommendation.

## SUMMARY OF REPORT

Many provisions throughout the codes contain a sunset date of January 1, 2021. This report is intended to assist the Legislature in determining how to handle those provisions, given the unprecedented challenges stemming from the COVID-19 pandemic.

The report is purely informational in nature. In this report, the Commission does not take any position on the substantive merits of any particular sunset provision.

This report was prepared pursuant to Government Code Section 8298.



## PENDING SUNSET DATES

1 Many statutes include a sunset provision, which specifies that a provision of law  
2 will be repealed or become inoperative on a particular date. This report focuses on  
3 statutes with a sunset date of January 1, 2021 (hereafter, a “1/1/21 sunset date”).

4 In an ordinary year, there is ample opportunity for persons interested in extending  
5 or eliminating a sunset date to express their views, and for the Legislature to craft  
6 and consider the merits of legislation to accomplish that result. If a statute warrants  
7 continuation (either indefinitely or for a specified time period), the Legislature can  
8 remove or adjust the sunset date, as appropriate.

9 Due to the COVID-19 pandemic, this year’s legislative schedule has been  
10 interrupted and constrained in unprecedented ways. Further disruptions of the  
11 legislative process might still occur. In addition, the Legislature is facing a host of  
12 urgent and critical issues relating to the pandemic. As a result, it might not be  
13 possible to give as much legislative attention as usual to the impending sunset dates.  
14 That might lead to an inadvertent lapse or change in the law, with unfortunate  
15 consequences.

16 To assist the Legislature, the Commission gathered information on 1/1/21 sunset  
17 dates. This purely informational report presents and analyzes that information.

18 In this report, the Commission did not evaluate whether, as a matter of policy, any  
19 specific sunset date should be extended.<sup>1</sup> The sole purpose of this report is to provide  
20 objective information and neutral drafting suggestions that might be useful to the  
21 Legislature in addressing the 1/1/21 sunset dates.

22 The report begins by explaining precisely which provisions the Commission  
23 included in its analysis. Next, the report classifies those provisions in several  
24 categories and discusses relevant circumstances for each category.

25 The report concludes with some technical observations on how legislation to  
26 temporarily extend 1/1/21 sunset dates might be drafted.

## SCOPE

27  
28 In preparing this report, the Commission reviewed the codes to identify all 1/1/21  
29 sunset dates. For the purpose of this report, the term “1/1/21 sunset date” includes  
30 all of the following:

- 31 • A provision that would be repealed, or become inoperative, by its own terms  
32 on January 1, 2021.<sup>2</sup>

- 1 • A provision that would repeal, or render inoperative, one or more *other*  
2 provisions of law on January 1, 2021.<sup>3</sup>
- 3 • A provision that says certain provisions of law should be treated as if they  
4 would become inoperative or be repealed on January 1, 2021.<sup>4</sup>
- 5 • A provision expressly stating that a reporting requirement will become  
6 inoperative, based on Government Code Section 10231.5, on January 1,  
7 2021.<sup>5</sup>
- 8 • A set of paired “sunset/sunrise” provisions, where the first provision (the  
9 sunset provision) is operative until a specified date and the second provision  
10 (the sunrise provision) becomes operative on that same date. This report  
11 includes such paired provisions if the repeal date of the sunset provision is  
12 January 1, 2021, even if the sunset/sunrise transition would operate earlier  
13 than that date.<sup>6</sup>

14 The Commission did not include provisions that otherwise use January 1, 2021,  
15 as a date with legal effect. For example, the analysis does not encompass a provision  
16 that requires submission of a report by January 1, 2021,<sup>7</sup> or a rule that commences,  
17 changes, or ends on January 1, 2021.<sup>8</sup>

#### 18 CATEGORIZATION OF PROVISIONS 19 WITH 1/1/21 SUNSET DATES

20 The provision listed in this report have been divided into four tables. This was  
21 done because the posture of each provision could affect the Legislature’s analysis  
22 of the provision. To make that analysis easier, the provisions have been grouped  
23 together along those lines. The content of each table is described below.

1 **Table 1. Miscellaneous Provisions with 1/1/21 Sunset Dates Affected by Pending Bill**

2 With exceptions addressed by Tables 3 and 4 below, Table 1 lists all of the code  
3 sections that meet both of the following criteria:

- 4 (1) The section contains a 1/1/21 sunset clause.  
5 (2) The sunset clause would be affected by a bill that is pending before the  
6 Legislature.<sup>9</sup>

7 For each such provision, the table quotes the key language in existing law (the  
8 1/1/21 sunset clause and, in some instances, a corresponding sunrise clause),  
9 identifies the pertinent pending bill, indicates when that bill was last acted upon,  
10 and shows whether the bill includes an urgency clause or other uncodified provision  
11 that may be relevant to revision of the sunset clause (i.e., a “plus section”).

12 Where a provision is currently included in multiple pending bills, the bills that  
13 would amend the sunset are listed first in the table. Any bill that would not affect  
14 the sunset is identified with a footnote specifying that the bill would make no change  
15 to the sunset.

16 **Table 2. Miscellaneous Provisions with 1/1/21 Sunset Dates Not Affected by Pending Bill**

17 Many code provisions that contain a 1/1/21 sunset clause do not have a  
18 corresponding, pending bill that would revise the sunset clause.<sup>10</sup> Those provisions  
19 are listed in Table 2.

20 In some cases, a section listed in Table 2 would be affected by a pending bill, but  
21 that bill would not directly affect the sunset clause (i.e., the bill would make some  
22 other unrelated change to the section). Information about such tangentially-related  
23 bills has not been included in Table 2.

24 **Table 3. Business and Professions Code Provisions**

25 The Business and Professions Code includes a large number of provisions that  
26 contain 1/1/21 sunset dates that would be affected by pending legislation.<sup>11</sup> Table 3  
27 lists those provisions.

28 Many of the sunset dates in Table 3 relate to the Joint Sunset Review Oversight  
29 work undertaken by the Assembly Business and Professions Committee and the  
30 Senate Business, Professions, and Economic Development Committee.<sup>12</sup> In the  
31 course of preparing this report, the Commission reached out to staff on those  
32 committees.

1 Based on that correspondence, the Commission understands that (1) many of the  
2 1/1/21 sunset dates in the Business and Professions Code are currently addressed in  
3 committee-authored legislation and (2) the remainder are not at risk for inadvertent  
4 lapse.<sup>13</sup> For this reason, the 1/1/21 sunset dates in the Business and Professions Code  
5 subject to pending legislation are grouped in their own table.

6 Where a provision is currently included in multiple pending bills, all of the  
7 pending bills are noted in the table. The table does not distinguish between bills that  
8 would amend the sunset and those that would not.

9 **Table 4. Labor Code Section 2750.3**

10 Labor Code Section 2750.3 is a lengthy, controversial section that addresses  
11 whether a person providing labor or services for remuneration is an employee, as  
12 opposed to an independent contractor. The section includes a paragraph specifically  
13 relating to a newspaper distributor or newspaper carrier, which by its terms, will  
14 become inoperative on January 1, 2021.<sup>14</sup>

15 Section 2750.3 is addressed in over thirty pending bills. Two of those bills propose  
16 to eliminate the inoperative date and indefinitely continue the legal requirements  
17 relating to a newspaper distributor or newspaper carrier.<sup>15</sup> In the remaining bills, the  
18 inoperative date would be unchanged or the substantive changes would be so  
19 significant that the section would be repealed and replaced altogether.<sup>16</sup>

20 Given the wide range of different legislative proposals focused on this section, it  
21 is clear that the content of the section is being closely scrutinized. Because the  
22 posture of the section is unique, information about it is provided in a separate table.  
23 Table 4 lists the bills that would affect Labor Code Section 2750.3.

24 ANALYSIS AND POSSIBLE LEGISLATION

25 The Legislature may wish to introduce an omnibus bill to extend certain 1/1/21  
26 sunset dates by one year, so that those sunsets would instead operate on 1/1/22.

27 This would be appropriate, for instance, if the Legislature determines that a 1/1/21  
28 sunset date should perhaps be extended, but that the present emergency makes it  
29 impractical to commit the resources required to fully consider the matter this year.  
30 The status quo would then be preserved for one year, allowing the Legislature to  
31 revisit the matter on its merits in 2021.

32 Even if legislation to adjust a 1/1/21 sunset date is already pending before the  
33 Legislature and is making steady progress toward enactment, it might be prudent to

1 include the affected provision in an omnibus bill. This would serve as a safety net,  
2 preventing an unintended gap in the law's effect that might occur if the present  
3 emergency somehow interferes with the more targeted bill's progress.

4 **To best serve such a purpose, the omnibus bill should include a subordination**  
5 **clause.** In the event that another bill that affects a section in the omnibus bill is  
6 eventually enacted, that other bill would control over the omnibus bill, regardless of  
7 the order in which they are enacted. A subordination clause is routinely used in the  
8 Maintenance of the Codes bill and similar omnibus technical bills, to prevent a  
9 technical amendment from chaptering out a more significant change made in  
10 another bill (without the need for numerous double-jointing provisions).

11 With a subordination clause, an omnibus bill would only affect a 1/1/21 sunset  
12 date if no other bill affects the same provision.

13 As noted above, the categorization used in Tables 1-4 is intended to assist the  
14 Legislature in deciding whether any 1/1/21 sunset dates should be included in an  
15 omnibus sunset extension bill. Each table reflects a different posture that might be  
16 relevant to the Legislature's analysis. The implications of those postures are  
17 summarized below.

- 18 • **Table 1.** All of the sunset dates listed in Table 1 are the subject of one or more  
19 pending bills that would affect the sunset date. The existence of those bills  
20 suggests that there is some legislative interest in extending those sunset dates,  
21 rather than letting them operate. Most of the related bills are making good  
22 progress toward enactment. Those efforts may be sufficient to ensure that the  
23 Legislature's purposes are served. However, the Legislature should consider  
24 whether to include such provisions in an omnibus bill, as a hedge against the  
25 possibility that things might change in way that further limits the resources  
26 available in 2020.
- 27 • **Table 2.** This table lists sunset provisions for which there is no bill that would  
28 affect the sunset date. This suggests that the Legislature may have concluded  
29 that it is proper that those sunset provisions operate on 1/1/21. If so, then there  
30 would be no need to include them in omnibus legislation. However, it might  
31 be worth reviewing the list to make sure that the absence of any legislation to  
32 change the sunset date is not inadvertent. In the current pandemic, the  
33 Legislature and affected groups have their hands full with high-priority  
34 emergency work, at a time when resources are unusually constrained. It might  
35 be that some 1/1/21 sunset dates listed in Table 2 should be extended, but  
36 have simply slipped through the cracks.
- 37 • **Table 3.** The provisions listed in Table 3 are sunsets from the Business and  
38 Professions Code that would be affected by pending legislation. A number of  
39 these provisions relate to the Joint Sunset Review Oversight work conducted  
40 by the Legislature. The Commission understands that these provisions are not  
41 at risk of inadvertent lapse and, for that reason, may not need to be included  
42 in omnibus legislation. However, the Legislature could include these  
43 provisions if it wishes to provide a backstop for the other pending bills. If the  
44 omnibus legislation includes a subordination clause, there would be no  
45 obvious disadvantage to doing so.
