# **Open Government Laws**

The Commission considered Memorandum 2025-3, summarizing "open government" laws applicable to the Commission. No Commission action was required or taken.

#### 2025 LEGISLATIVE PROGRAM

The Commission considered Memorandum 2025-5, discussing the Commission's 2025 legislative program.

No Commission decisions were required or made.

The Commission considered the following memoranda:

• Memorandum 2025-11, presenting initial recommendations for ACR 95

questions and Supplements 1 and 2 thereto.

The Commission took the following actions on the initial recommendations:

- The Commission voted to approve the staff recommendation to direct the staff to draft recommendations revising California's antitrust laws. Commissioner Cubas was not present.
- The Commission voted to approve the staff recommendation that California adopt its own single firm conduct provision, different from federal law. Senator Blakespear and Commissioner Cubas were not present.
- The Commission voted to direct the staff to propose standards to the Commission that guard against the misuse of market power to any new single firm conduct provision. Commissioners Cubas and Huebner and Senator Blakespear were not present. Commission Simpson voted no.
- The Commission voted to approve the staff recommendation against Big Techspecific antitrust laws and instead to instead ensure that any proposed antitrust language is drafted sufficiently broad and flexible enough to encompass Big Tech as well other industries. Commissioners Cubas and Huebner and Senator Blakespear were not present.
- The Commission voted to approve the staff recommendation that California adopt its own merger approval and premerger notification laws. Commissioners Cubas and Huebner and Senator Blakespear were not present.
- The Commission directed staff to provide additional information to the Commission on the current standard and burdens of proof in the context of merger laws before taking further action on the issue.
- The Commission directed staff to staff review the remaining recommendations and suggestions relating to Antitrust Law that have been provided to the Commission after the Commission considers the broader changes to single firm conduct and merger review and then calibrate the possible impact of further reforms.

## STUDY E-200 — RECODIFICATION OF TOXIC SUBSTANCE STATUTES

The Commission considered Memorandum 2025-6, presenting a recurring cumulative draft of proposed recodified provisions of Chapter 6.5 of Division 20 of the Health and Safety Code that have been provisionally approved by the Commission for inclusion in a future tentative recommendation in this study.

The Commission provisionally approved addition to the recurring cumulative draft of two proposed Notes shown in the draft following proposed Section 64160.

The Commission also considered Memorandum 2025-7, presenting a staff draft of

additional proposed recodified provisions of Chapter 6.5 for provisional inclusion in the future tentative recommendation.

The Commission provisionally approved the inclusion of the additional proposed recodified provisions in that future tentative recommendation.

# STUDY G-300 — STATE AND LOCAL AGENCY ACCESS TO CUSTOMER INFORMATION FROM COMMUNICATION SERVICE PROVIDERS

The Commission considered Memorandum 2025-8, presenting updated proposed legislative language based on stakeholder feedback.

The Commission approved the language without changes for a tentative recommendation to be considered at the next meeting.

## STUDY I-100 — EQUAL RIGHTS AMENDMENT

The Commission considered Memorandum 2025-9, presenting revised draft proposed legislative language and an update on work to identify and remedy specific defects.

The Commission approved the memorandum without changes for the purposes of a tentative recommendation to be considered at the next meeting.

## STUDY I-200 — TERMINOLOGY RELATING TO PERSONS WITH DISABILITIES

The Commission considered Memorandum 2025-10, introducing this study and identifying next steps intended to be taken in the study by staff. No Commission action was required or taken.
